Regulations Concerning Foreign Researchers of the Institute of Japan Studies of Tokyo University of Foreign Studies

Article 1 Purpose

These Regulations provide the necessary matters relating to handling in cases where the Institute of Japan Studies of Tokyo University of Foreign Studies (excluding Senior Language Lecturers and Language Lecturers as stipulated in the Working Regulations for Specified Fixed-Term Employees of Tokyo University of Foreign Studies (2008: Regulation No. 26)).

Article 2 Definition

The term "Foreign Researcher(s)" means foreign researchers who are jointly engaged in research at the Institute for the purpose of contributing to the advancement of science and are professors, associate professors, lecturers, or junior lecturers of foreign universities or academic research institutes or have been recognized as having research results equivalent thereto.

Article 3 Application

The Research Representative (i.e., professors, associate professors, lecturers, and junior lecturers of the Institute) who intends to accept Foreign Researchers shall apply for acceptance of such foreign researchers to the Dean of the Institute in the prescribed form at least three (3) months prior to the scheduled acceptance.

Article 4 Approved

If the application is filed under the preceding paragraph, the Dean of the Institute shall approve acceptance thereof in the prescribed form through deliberation by the Faculty Council.

Article 5 Length of time

- 1 The acceptance period for a Foreign Researcher shall be one (1) month or more but not exceeding one (1) year, in principle.
- The period set forth in the preceding paragraph may be renewed if it is found necessary to continue the research. In such case, the provisions of the preceding two (2) articles shall apply mutatis mutandis to the procedures for renewal. However, such acceptance period shall not exceed three (3) years in total.

Article 6 Grant of Title

- The Dean of the Institute may apply to the President of the University for the grant of the title of Visiting Professor of Tokyo University of Foreign Studies to any Foreign Researcher who falls under any of the following items through deliberation by the Faculty Council.
 - (1) A person who is found to have a qualification equivalent to or superior to that of a professor of the University; or
 - (2) A person who is accepted for a continuous period of three (3) months or more.
- 2 Upon application under the preceding paragraph, the President may grant the title to any person whom he/she deems appropriate.

Article 7 Research

Foreign Researchers shall conduct research in accordance with the research plan submitted in advance.

Article 8 Use of Facilities, etc.

Foreign Researchers may use various facilities and equipment necessary for their own research to the extent that will not interfere with the education and research of the University.

Article 9 Salary, etc.

- 1 No salary shall be paid to Foreign Researchers.
- 2 Travel expenses, living expenses, and other expenses shall be borne in principle by Foreign Researchers themselves.

Article 10 Observation of Regulations, etc.

Foreign Researchers shall observe the rules and regulations of the University.

Article 11 Cancellation of Acceptance Approval

The Dean of the Institute may cancel the acceptance of Foreign Researchers if he/she finds them inappropriate as such. In such case, Article 4 shall apply mutatis mutandis to the procedures for cancellation.

Article 12 Mutatis Mutandis

These Regulations shall apply mutatis mutandis to researchers who belong to foreign universities or academic institutions (limited to Professors, Associate Professors, Lecturers, Junior Lecturers, or those with equivalent research achievements) who have Japanese nationality.

Article 13 Miscellaneous Provisions

Any matters not set forth in these Regulations concerning the Foreign Researchers shall be prescribed separately.
