Regulations Concerning International Students of Tokyo University of Foreign Studies

Article 1 Purpose

These Regulations provide for necessary matters relating to international students in accordance with Article 51, paragraph 2 of the University Regulations of Tokyo University of Foreign Studies and Article 43, paragraph 2 of the Graduate School Regulations of Tokyo University of Foreign Studies Graduate School.

Article 2 Status

The status of international students accepted shall be as follows:

- (1) Undergraduate Students
- (2) Graduate Students.
- (3) Research Students
- (4) Non-degree Students
- (5) Special Audit Students
- (6) Special Research Students
- (7) Japanese Studies Students
- (8) Teacher Training Students
- (9) Japanese Language Center for International Students
- (10) Special Program Students
- (11) Contract Students
- (12) Short Visiting Students

Article 3 Special provisions for the period of enrollment of international students receiving Japanese Government Scholarship

The period of enrollment of international students listed in the preceding article, who are in accordance with the Guidelines for the Implementation of the Japanese Government Scholarship Program (Ruling of the Minister of Education, Culture, Sports, Science and Technology, March 31, 1954) (hereinafter referred to as the "Guidelines"), may be considered as the period of payment of the Japanese Government Scholarship salary.

Article 4 Acceptance, etc. of Japanese Studies Students and Teacher Training Students

- The acceptance of Japanese Studies Students and Teacher Training Students shall be decided through consultation between the Minister of Education, Culture, Sports, Science and Technology and the President.
- In the course of training and guidance, Japanese Studies Students shall be treated in the same manner as the special audit students enrolled in the Undergraduate Schools.
- 3 In the course of training and guidance, Teacher Training Students shall be treated in the same manner as the special audit students enrolled in the Graduate School.
- 4 Japanese Studies Students and Teacher Training Students shall submit their respective research reports to the President through their respective academic supervisors within one (1) month before the end of the study period.
- The President shall issue a certificate of completion to any person who has completed the prescribed course.

Article 5 Acceptance of International Students at Japanese Language for International Students Japanese Language Center for International Students acceptance of international students shall be conducted in accordance with the Regulations regarding the education of Japanese Language Center for International Students of Tokyo University of Foreign Studies (established on November 18, 1992).

Article6 Acceptance of Special Program Students, etc.

- 1 Acceptance of special program students, etc. shall be conducted in accordance with the Tokyo University of Foreign Studies Special Program Regulations (established on March 22, 2022).
- The status of a Special Program Student shall be a special audit students prescribed by Article 50 of Regulations of Tokyo University of Foreign Studies and Article 41 of Graduate School Regulations of Tokyo University of Foreign Studies..

Article7 Acceptance of Entrusted International Students etc.,

Acceptance etc., of entrusted international students shall be conducted in accordance with the

- Regulations on Entrusted Foreign Students of the Tokyo University of Foreign Studies (established on March 22, 2022).
- The treatment of entrusted international students in the course of training guidance shall be conducted in the same manner as that of special audit students.

Article 8 Acceptance, etc. of Short-term Overseas Visiting Students

Acceptance of short visit students, etc. shall be conducted in accordance with the Short Visit Student Regulations (established on March 22, 2022).

2 Short-term overseas visiting students shall be treated in the training guidance in the same manner as special auditing students.

Article 9 Application Mutatis Mutandis of School Regulations, etc.

In addition to matters prescribed in these Regulations, the following shall mutatis mutandis to necessary matters for studies pertaining to international students: Regulations of Tokyo University of Foreign Studies and Regulations of Graduate School of Tokyo University of Foreign Studies etc., shall apply mutatis mutandis to matters necessary for foreign students in their studies.
